Vendors are responsible for the quality and safety of what they sell and agree to indemnify White Rock Local Market for any claims arising from the sale of any products, the failure to obtain any necessary licenses or permits or the negligence of any vendor or their employees, representatives or agents.

**FEES**

Food products: \$25 per vendor/per market.  
Produce vendors (75% or more produce): \$10 per vendor/per market

Please do not send payment or apply for a city of Dallas permit until White Rock Local Market has contacted you to confirm your participation in the market. WRLM will contact you to confirm participation.

**FORFEITURES**

Payment for booth space will be collected on market day. If you do not plan to participate in a market, 24 hour notice is required. Otherwise you will be charged for your booth space.
